




**Maturity Distribution, November 2020**

# Economic and Market Commentary November 2020

In the U.S., the 2-year Treasury note yield remained at 0.15%. The yield on the benchmark 10-year Treasury was 0.84%, down from 0.87% at the end of October. The much-awaited U.S. election concluded with former Vice President Joe Biden defeating Donald Trump. Covid-19 cases and hospitalizations surged globally, particularly in the euro area and the U.S. equity markets had their best month since April, on the back of stellar news on the clinical trials of the Pfizer, Moderna, and AstraZeneca vaccines and with a near conclusion of the Presidential transition process.

The unemployment rate was 6.9% in October and firms added 638,000 net, new jobs to nonfarm payrolls over the month. The labor market further improved in November, although not at the same dramatic clip experienced in recent months. Nonfarm payroll employment rose by 245k versus consensus expectations for 450k, and the unemployment rate fell to 6.7%. The U.S. economy posted a 33.1% annualized increase in real GDP for Q3 (7.4% quarter-over-quarter), retracing almost two-thirds of the decline since Q4 2019. The US service sector PMI for November improved to an expansionary level of 58.4, with an index reading above 50 indicating growth.

Towards the end of the month, Treasury Secretary Mnuchin made headlines when he formally requested that the Fed return the money appropriated by Congress for certain emergency lending facilities. The emergency facilities in question were opened during the March financial panic under the auspices of keeping credit flowing to households and business. While the media focused on the risks of pulling funding too early and Fed Chair Jerome Powell hesitant to comply with the request, the five lending facilities that were stripped of funding had been scarcely used. Despite the public spat in an otherwise friendly Fed-Treasury relationship, the media attention was much ado about nothing. The Fed remains committed to maintaining easy monetary conditions until the labor market has fully recovered.

## FL Trust Short Term Bond Fund

The Florida Trust Short Term Bond Fund posted a total return of +0.11% in November, compared to ICE BofA 1-3 Year Treasury Index return of 0.05%. The net 30-Day SEC Yield for the Short-Term Bond Fund was 0.42% at the end of November, up from 0.38% ending October.

The Florida Trust Short Term Bond Fund holds a diversified mix of sectors for income generation. We are focused identifying the most efficient sources of income for the portfolio, as we believe the income component of total return will be the key driver for overall portfolio performance for the remainder of the year. We maintain liquidity and government allocations, using additional sectors as a source of high quality, highly liquid spread product that must be favorable on several metrics. We are actively purchasing corporates, asset-backed securities, agency pass-through mortgages, and government related securities. We have allowed the corporate exposure to drift lower as spreads have tightened aggressively since March. We continue to maintain higher exposure to agency mortgage-backed securities versus where we have been historically; these serve as an alternative to high quality credit, but with a better liquidity profile and higher yielding versus Treasuries. We continue to view ABS favorably and have been actively participating in new issue. This sector has some positive tailwinds, given much lower issuance compared to corporates.

The fund is assigned Fitch rating agency's highest Fund Credit Quality Rating and Fund Market Risk Sensitivity Rating of AAAf/S1. The liquidity of the fund is very strong, with 47% of funds invested in Treasuries, agencies and government related securities. There were no significant inflows or outflows during the month.
