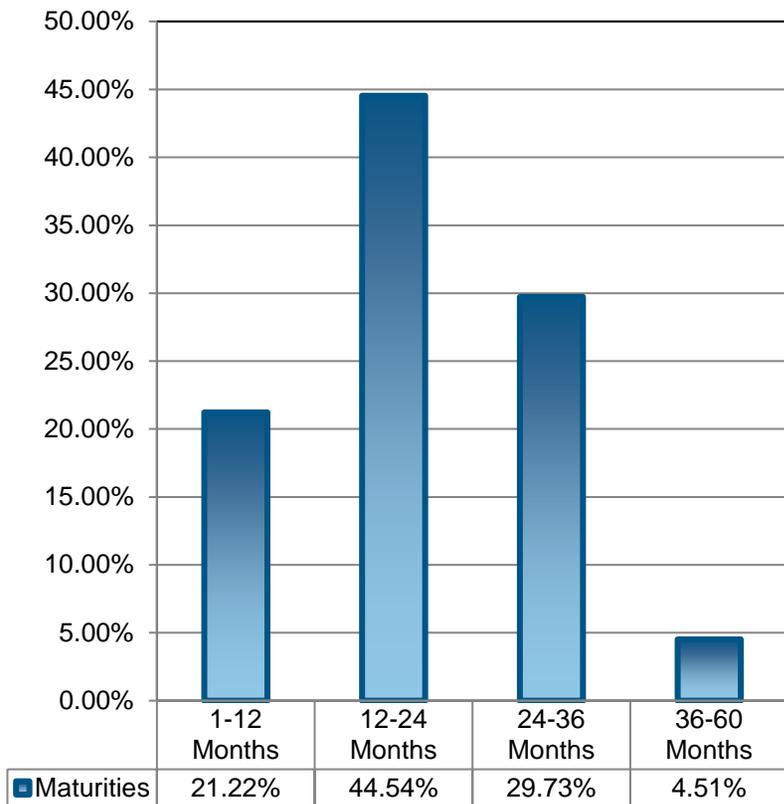

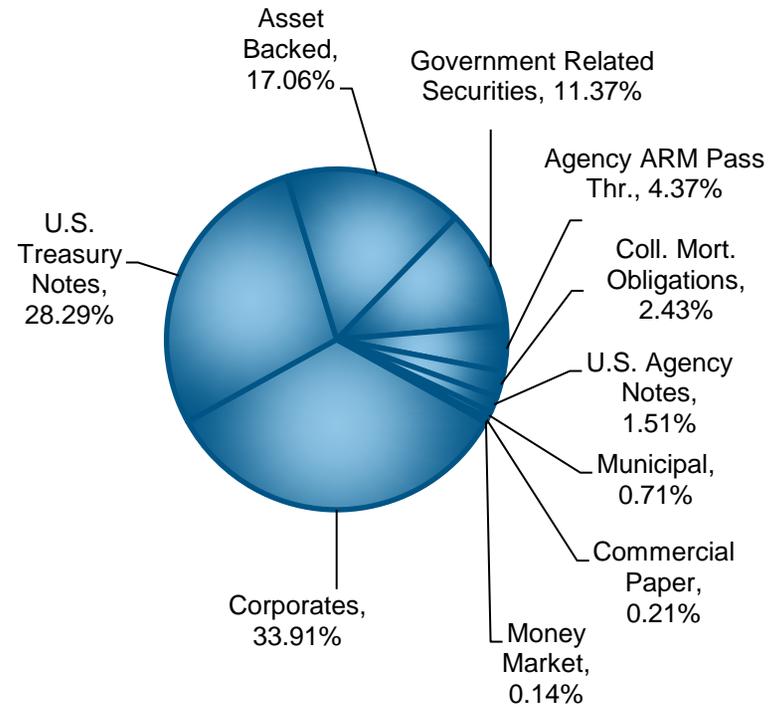

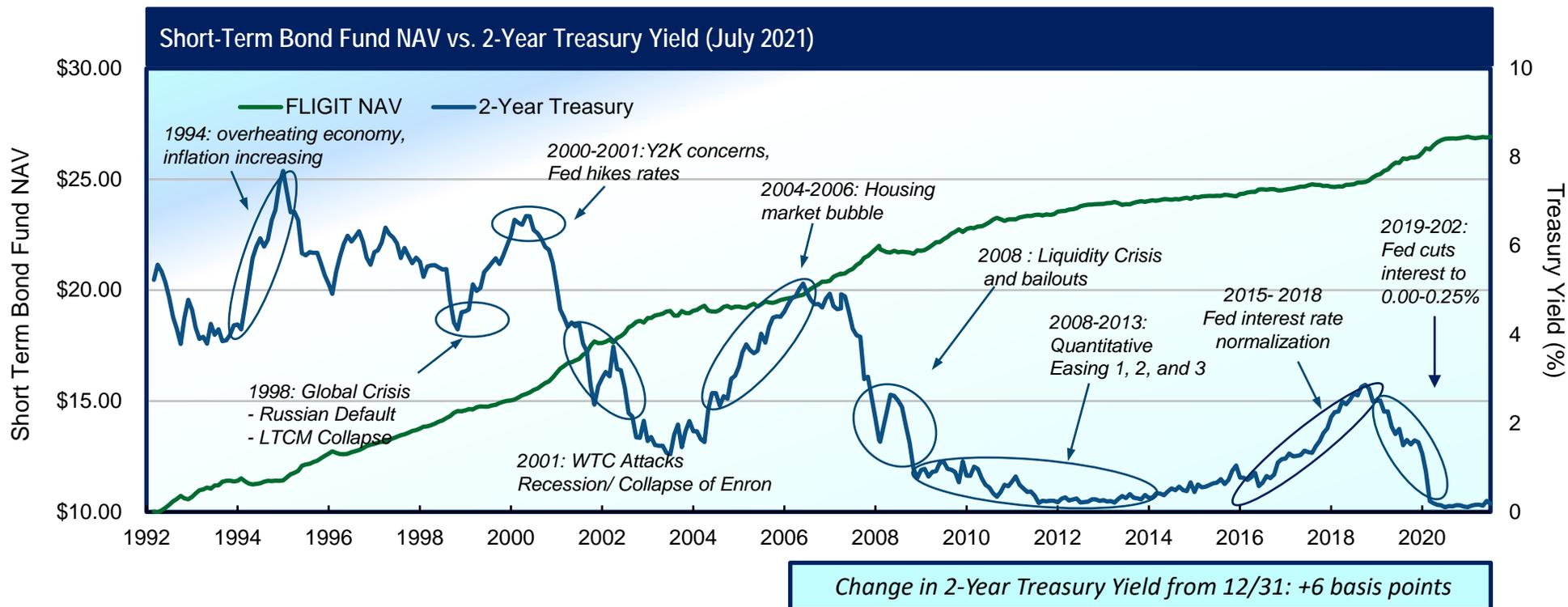
Maturity Distribution, July 2021

Economic and Market Commentary July 2021

The yield on the 2-year US Treasury note yield fell six basis points to 0.19% over the month. The yield on the benchmark 10-year Treasury declined 25 basis points to 1.22%.

The economic data released in July continued to show the challenges of reopening. Despite adding 850,000 jobs to nonfarm payrolls in June, the unemployment rate increased slightly to 5.9%. Supply bottlenecks combined with strong demand for goods continued to push consumer prices higher, with headline and core CPI reaching 5.4% and 4.5%, respectively. The Fed's preferred inflation gauge, core PCE, was more subdued at 3.5% year-over-year for June. Gross domestic product data released at the end of the month revealed that the U.S. economy grew at a 6.5% annualized rate in June, missing expectations of near double-digit growth due to the depletion of inventories. The miss was bittersweet, however, because it signaled that the U.S. might grow at a faster rate than initially predicted in the second half of the year as companies replenish their stockpiles.

As is typical, tapering and inflation were the primary topics discussed in the policy statement and press conference after the July Federal Open Market Committee (FOMC) Meeting. Regarding tapering, policymakers acknowledged that the labor market has "made progress" toward the goal of "substantial further progress," but pledged to "continue to assess progress in coming meetings." Powell also acknowledged there is little support within the Committee to reduce purchases of mortgage-backed securities (MBS) before Treasuries, but that there is some support for reducing them "at a faster pace" once a taper is announced. Regarding inflation, Powell clarified that "transitory" means the recent rises in prices will likely level off and stabilize but will not leave permanent marks on the inflation process in the form of rapidly rising inflation expectations or ever-higher wage demands. Ultimately, the FOMC has yet to decide when and how to taper its asset purchases and will continue to look past current inflationary pressures and remain patient into the fall.

FL. Trust Short Term Bond Fund

The Florida Trust Short Term Bond Fund posted a total return of 0.16% in July, compared to ICE BofA 1-3 Year Treasury Index return of 0.17%. The fiscal-year-to-date (October 1), total return was 0.48%, versus 0.14% for the benchmark. The net 30-Day SEC Yield for the Short-Term Bond Fund was 0.29% at the end of July, up one basis point from June month end.

The Florida Trust Short Term Bond Fund holds a diversified mix of sectors for income generation. We identify the most efficient sources of income for the portfolio, with a focus on high-quality liquidity. Currently tight spreads and light supply have limited our ability to add further to government-related and agency allocations in the portfolio. We continue to emphasize a balance between credit diversification and quality using corporates, asset-backed securities (ABS) and mortgage-backed securities (MBS), to maintain diversified sources of high-quality income. We utilize corporate issuance to optimize positioning and exposure to floating rate securities to generate portfolio income without extending duration. The modestly short duration positioning versus the benchmark helps mitigate the impact of rising rates. While all-in yields are low, incremental yield from spreads remain attractive and demand for short-dated credit remains robust.

The fund is assigned Fitch rating agency's highest Fund Credit Quality Rating and Fund Market Risk Sensitivity Rating of AAf/S1. The liquidity of the fund is very strong, with 41% of funds invested in Treasuries, Agencies, and government related securities. The fund did not process any withdrawals or contributions in July.
