




Maturity Distribution, December 2021

Economic and Market Commentary December 2021

The yield on the 2-year US Treasury note rose 17 basis points to 0.73% over the month. The yield on the benchmark 10-year Treasury rose seven basis points to 1.51%.

Consumer prices continued to climb higher in the U.S. in November, with the headline CPI reading reaching 6.8% year-over-year. Trimmed-mean and median measures of inflation also sit uncomfortably above the Fed's target, with trimmed mean PCE reaching 2.8% year-over-year in November. Despite only 210,000 jobs being added to payrolls in November, the unemployment rate fell to 4.2%. However, the overall employment level and labor force participation remain suppressed compared to pre-Covid levels.

Short interest rates moved higher throughout Q4 as investors priced in the potential for multiple interest rate increases in 2022, and ultimately the Federal Reserve pivoted to a more hawkish stance amid worries about the potential for high inflation to persist. At the December FOMC meeting, the Fed decided to speed up the pace of the tapering of the asset purchase program, noting maximum employment was near and elevated inflation was problematic. Projections released by the FOMC after the meeting showed the median policymaker saw three policy rate hikes in 2022 (in-line with market expectations) if the economy progresses as expected, up from one after the September FOMC meeting.

FL Trust Short Term Bond Fund

The Florida Trust Short-Term Bond Fund posted a gross total return of -0.12% in December, compared to ICE BofA 1-3 Year Treasury Index return of -0.25%. Calendar year-to-date returns for the Fund are -0.33% versus the benchmark return of -0.55%. The net 30-Day SEC Yield for the Short-Term Bond Fund was 0.49% at the end of December, up seven basis points from November month end.

As market pricing of the hiking cycle was pulled forward, the short part of the Treasury yield curve steepened, while the long end flattened. Continued strong demand for ultra-short maturity fixed income outweighed the impacts of tapering and increased bill supply. The one-year U.S. Treasury bill moved up 31 basis points ("bps") over the quarter to 0.38%, while two and three-year yields increased 45 bps to 0.73% and 0.96%, respectively. Low yield levels mean even modest rises in rates erode positive return on a short-term basis. Over longer time periods, the combination of both income and active total return management should result in outperforming the yield of the portfolio, currently 0.49% (30-day net-yield), up from 0.35% at the end of September. With higher yields, income earned in the portfolio gets reinvested at more favorable rates. A steeper front-end curve is also positive for forward-looking total return potential.

The Florida Trust Short-Term Bond Fund continues to hold a diversified mix of sectors for income generation. We identify the most efficient sources of income for the portfolio, with a focus on high-quality liquidity. We continue to emphasize a balance between credit diversification and quality using corporates, asset-backed securities (ABS) and mortgage-backed securities (MBS), to maintain diversified sources of high-quality income. We utilize corporate issuance to optimize positioning and exposure to floating rate securities to generate portfolio income without extending duration. We continue to position the portfolio defensively to protect against higher interest rates. We accomplished this by maintaining a shorter duration position relative to the benchmark and holding an allocation to floating-rate securities. We further shortened our duration positioning over the course of the quarter. While all-in yields are low, incremental yield from spreads remain attractive and demand for short-dated credit remains robust.

The fund is assigned Fitch rating agency's highest Fund Credit Quality Rating and Fund Market Risk Sensitivity Rating of AAAf/S1. The liquidity of the fund is very strong, with 40% of funds invested in Treasuries, Agencies, and government related securities. The fund received over \$86 million in net contributions during December, ending the year with \$1,026.2 million in assets.
