V. Additional instructions

1. Please call the Trust Operations Team to receive a Security Code Number, if the local government has not received one previously.
2. Employees of the local government may have access to the Assets Under Management (AUM) System via the internet. An AUM form will be provided, so that logins may be created for those employees who will need access. The local government may designate such employees as having read only access or transaction access. The AUM system can be used to:
 - a. Download monthly statements.
 - b. Check the local governments account balance.
 - c. Withdraw funds (if the employee has transaction access).
3. An investment in the Fund is not insured or guaranteed by the Federal Deposit Insurance Corporation or any other government agency. The ratings are not intended to consider the prospective performance of a fund with respect to appreciation, volatility of net asset value, or yield. Money market funds rated AAA are judged to be of an investment quality similar to AAA-rated fixed income obligations, that is, they are judged to be of the best quality.
