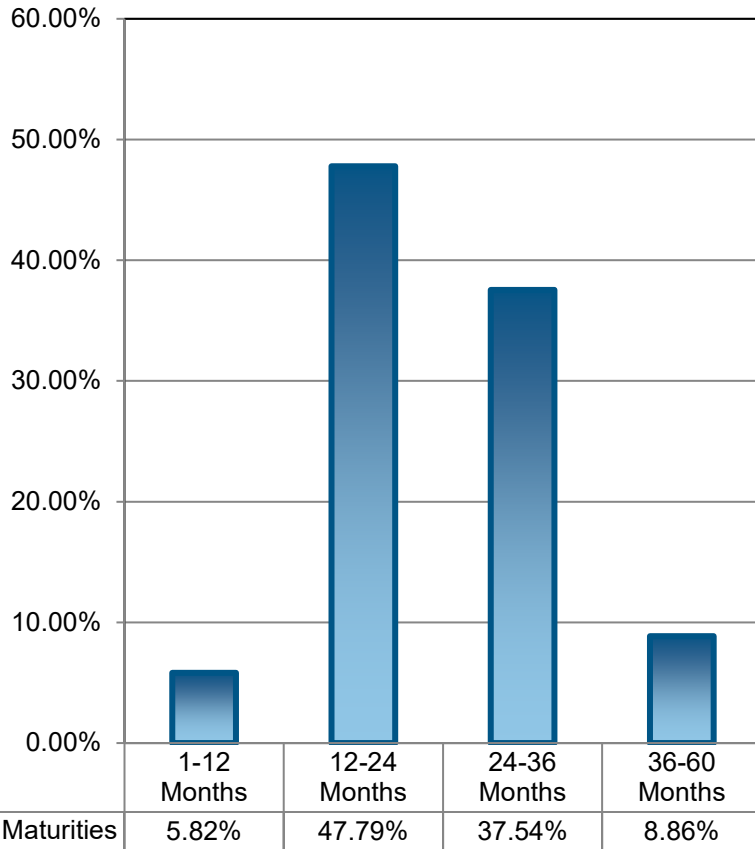

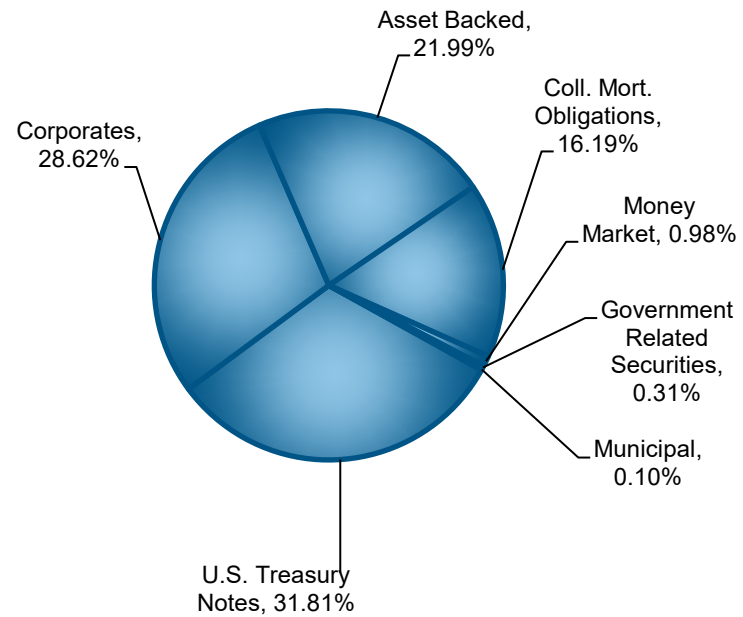

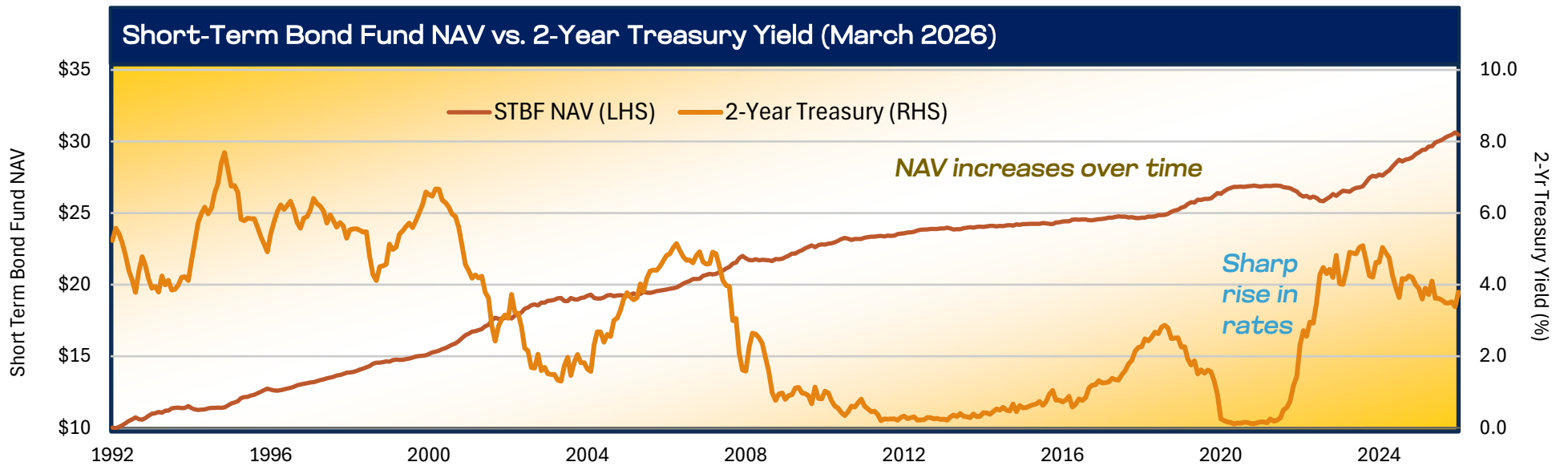

Economic and Market Commentary March 2026

The conflict in Iran dominated markets in March, pushing bond yields higher amid rising inflation concerns. In the U.S, the yield on the 2-year Treasury rose 44 basis points (“bps”) to 3.81%. The yield on the benchmark 10-year Treasury rose 38 bps to 4.32% and the yield on the 30-year Treasury rose 30 bps to 4.91%.

Data released showed the U.S. economy expanded at a moderate 2.1% pace in 2025, despite headwinds from tariffs and restrictive monetary policy. In February, the labor market lost 86,000 private-sector jobs - the largest monthly contraction in more than five years—pushing the unemployment rate up to 4.4%. Meanwhile, core personal consumption expenditures (PCE) inflation edged up to 3.1% year-over-year in January, driven by lingering tariff-related price pressures and seasonal effects.

The Federal Reserve (Fed) held the federal funds rate steady at 3.75% in March amid stickier-than-expected core inflation and a relatively stable unemployment rate. The latest Summary of Economic Projections (SEP) indicates that policymakers are comfortable remaining on hold, with the median participant expecting only one rate cut in 2026. However, we are more concerned about labor market weakness and less worried about inflation than policymakers. While the recent oil price shock will push headline inflation higher in the near term, the pass-through to core inflation - which excludes food and energy - is likely to be limited without a pickup in private demand. Although core inflation may remain elevated in the near term, it should moderate more quickly in the second half of the year as tariff-related price pressures and persistently high non-housing services inflation begin to ease. As a result, we expect the Fed to remain on hold for most of the year, with labor market weakness and continued disinflation paving the way for rate cuts in late 2026 and early 2027.

Florida Trust Short Term Bond Fund

Short fixed income returns were negative across almost all sectors in March as the war in the Middle East has caused volatility in fixed income markets, pushing bond yields higher. Credit markets, already dealing with AI disruption anxiety, faced additional headwinds as geopolitical tensions ripple throughout all sectors. This has resulted in some modest spread widening in short fixed income in March (~10 bps wider). More impactfully, investors began to question whether the Federal Reserve will be able to pursue any additional easing in 2026, resulting in short Treasury yields 30-40 bp higher across 2-year and longer maturities.

The STBF posted a -0.60% total return for March, versus the benchmark ICE BofA 1-3 Year US Treasury index, which returned -0.44%. For the first quarter, the STBF returned +0.30% and the benchmark +0.29%; fiscal year-to-date, the STBF has returned +1.45% versus 1.41% for the benchmark.

The STBF remains well positioned as we continue to invest in a high-quality tilt and a diversified mix of credit, with ample liquidity, and modestly long duration position. The strong income component (3.82% SEC yield 3/31) should be additive to returns as negative bond price performance will cure over time. Our outlook for managing the STBF during this volatile period has been to stay the course, with modestly longer duration positioning and consistency in our outlook that inflation is less of a concern than soft labor markets, though remain cautious as the energy supply shock could upset this outlook with a prolonged conflict. As such, we expect the Fed to remain on hold until later in the year, anticipating rate cuts in late 2026 and early 2027. We continued to rotate older Treasury positions into more recent two- and three-year issues. Outside of U.S. Treasuries and government-related securities, we remain focused on high quality credit including corporates, asset-backed securities, and mortgage-backed securities for the fund. Credit markets adopted a more cautious tone during the month and spreads across credit markets widened from narrow levels. Exposure in securitized markets remains focused on the most senior, highest-quality segments of the securitized market.

The STBF is assigned Fitch rating agency's highest Fund Credit Quality Rating and Fund Market Risk Sensitivity Rating of AAf/S1. The net 30-Day SEC Yield for the fund was 3.82% as of 3/31, versus 3.87% 2025-year end. The liquidity of the fund is strong, with 32% of funds invested in Treasuries and government related securities. Net deposits to the fund reached over \$22 million in March.
